Axonaut Affiliate Program

The affiliate program offered by Digitica SAS (hereinafter referred to as "Affiliator") allows any legal entity (hereinafter referred to as "Affiliate") that uses the Axonaut software to be an Affiliate through a link that contacts will be able to click on in order to become a client. In return for this client contribution, the Affiliate will be compensated by the Affiliator in the form of a commission of €300. These terms of payment are defined below.

How is a client assigned to you?

On your PARTNER space, you have a link (URL) to share. If a contact registers on Axonaut via this link, he will be automatically attached to you (the Affiliate) and you will see it appear on your PARTNER space.

If it is not the case and you do not see your contact appear on your space, he did not use your link. You can then contact us (Digitica SAS) by email or by chat in the bottom right corner of the interface to give us all the necessary information allowing us to assign the contact to your PARTNER space: company, first name, last name, email and date.

How does the compensation work?

€300 (excl. VAT) are allocated to the Affiliate for each client brought via this Affiliate Program to the Affiliator once the latter (Digitica SAS) has received the first €300 (excl. VAT) of the subscription for the said client.

The final attribution of the compensation between the different possible contributors (affiliation, advertising, sponsorship) is left to the sole discretion of Digitica SAS.

The amount of the compensation may be modified at any time and without notice by Digitica SAS and will apply to any client registration after the change.

When the Affiliate wishes to be paid, the Affiliate must issue an invoice in the name of Digitica SAS with all the mandatory information clearly indicating the name(s) of the corresponding client(s). This program is therefore reserved for legal entities with the capacity to issue invoices.

In the case of a refund requested by the client and validated by the Affiliate, no amount will be owed to the Affiliate.

How long is the program?

The present conditions can be amended by Axonaut (Digitica SAS) without prior notice and without any communication other than the update of this document, the website and the portal of Axonaut affiliation.

If the contact has become a client upon acceptance of the terms and conditions applicable since the 25/08/2020 and the commission is due several months later (*case 1*) while the terms and conditions have evolved during this period, the Affiliate benefits from the present conditions (conditions applicable at the time of registration of the end client).

What is the Affiliate's commitment?

The Affiliate agrees not to spread, display, distribute, transmit, publish, incorporate links referring to information, documents, texts, images, videos, of an infringing nature, defamatory, racist or in general anything that could harm one's protected rights or which may associate the Affiliator (the Axonaut brand, the axonaut.com website, the company Digitica SAS) to illegal information. The Affiliate undertakes not to infringe on privacy, harass, threaten third parties, transmit computer viruses, interfere with, restrict or inhibit optimum use of computerized resources of axonaut.com or third parties.

What are the applicable law and competent jurisdiction?

In the event of a dispute over this Program, the parties agree to try to reach an amicable agreement. If they do not reach this agreement, the dispute will be submitted to the Commercial Court of Toulouse. The present conditions are governed by French law.
